The Japan Patent Office (JPO) announced on February 2, 2009 the release on its website of a series of videos entitled "Design Rights: Protector of Originality". Through these videos, the JPO seeks to provide an outline of the Japanese Design System and of the design application process, so as to enable even first time users to get a better understanding of the aims and basis of the system.

The videos, shot like a television series and divided in three episodes, are available in both Japanese and English.

#### The Agency for Cultural Affairs discloses a draft government ordinance adding Blue-ray discs to the Compensatory payment system; gathers public feedback; implementation scheduled for April 1, 2009 文化庁、ブルーレイ課金政令案公表し意見募集。2009年4月1日施行予定

The Agency for Cultural Affairs disclosed on February 3, 2009 a draft government ordinance partially revising a previous enforcement ordinance of the Copyright Law. This draft government ordinance adds Blueray disc recorders and the related recording formats to the list of products concerned by the Compensatory payment system regarding private music and video recording. The Agency will be gathering feedback from the public until March 4 and hopes for an implementation on April 1, 2009.

Adopted in 1992, the Compensatory payment system regarding private music and video recording makes payment of a compensatory amount compulsory in order to make up for the loss sustained by copyright holders as a result of the increase of private digital recording of music/video. The list of devices or mediums concerned by the system has been enlarged in accordance with the revisions of the Enforcement Ordinance of the Copyright Law. Recording mediums currently concerned by the system include DAT, MD, CD-R, CD-RW, D-VHS, DVD-RAM, DVD-R, DVD-RW, as well as the related sound/video recording devices. Following the new draft government ordinance, Blue-ray discs and the related recording devices will be added to the list. At this point, HDD recorders (such as Apple's iPod) remain unaffected by the system.

文化庁は2009年2月3日、ブルーレイディスクレコーダーとその記録媒体を私的録音録画補償金制度の対象に追加 する「著作権法施行令の一部を改正する政令案」を公表した。同年3月4日まで意見募集を行い、同年4月1日からの施 行を予定している。

私的録音録画補償金制度は、デジタル方式の録音・録画について私的録音録画の増大に伴う著作権者等の不利益 を補償するため、補償金の支払いを義務づけることを目的に1992年に導入された。その対象機器や媒体は著作権法施 行令の改正により追加されてきており、現在、対象となっているのは、DAT、MD、CD-R、CD-RW、D-VHS、DVD-RAM、 DVD-R、DVD-RWなど記録媒体とその録音、録画機器などで、これに今回、ブルーレイディスクとそのレコーダーが追 加される。なお、iPodなどのHDDレコーダーは見送られた。

### The JPO releases a draft revision of the Handbook of Guidelines for the Formal Examination regarding provisional patent licensing and gathers public feedback 仮実施権登録等に関する方式審査便覧改訂案公表、意見募集

A draft revision of the Handbook of Guidelines for the Formal Examination was released by the JPO on February 5, 2009, who will be gathering public feedback until March 6, 2009. The Handbook of Guidelines for the Formal Examination describes the criteria used during the Formal Examination, as well as its general concept.

This time, as a result of the 2008 partial revision of Japanese Industrial Property Law, a new system of temporary exclusive and non-exclusive license has been introduced. Further, the Guidelines have been revised with regard to the extension of the period to request an appeal. They also include explanations regarding the relationship between interested parties and the scope of disclosure, and regarding forms such as the inspection request form.
